# **VR Programming**

- VR Services in the field Jessica Cimini
  - Anyone with a disability 18+
- Job Placement and Workforce Development Joan Phillips
  - Work with adults with disabilities and employer partners
- Pre-Employment Transition Services (Pre-ETS) Jessica Cimini
  - Provides students (aged 14 up until 22<sup>nd</sup> birthday) with disabilities the opportunity to experience and explore the world of work.
- Rehabilitation and assistive technology Joan Phillips
  - Devices, aides, and enhancements used in rehabilitation technology. People with severe mobility, learning, emotional, visual, hearing, neurological, neuromuscular, and other disabilities may benefit from rehabilitation technology to increase function by decreasing barriers in the home and workplace.
- Benefits Specialists Joseph Reale
  - Support individuals in planning around employment and benefits
- NextGen Careers Joan Phillips
  - Targets young adults 18-30 with a wrap around model of VR service delivery focused on minority young adults and STEM careers.
